Order

Keeping in view the larger public interest in the scenario of emerging threat of Pandemic Covid-19, In continuous to earlier order No. 11-20/Spcl dated 21-08-2020 and keeping in view of latest guidelines received from the Government of Punjab, Department of Home Affairs and Justice, Chandigarh vide no SS/ACSH/2020/595 dated 21.08.2020. I, Ghanshyam Thori, IAS, District Magistrate, Jalandhar in exercise of powers conferred upon me under section 144 of CrPC 1973 and National Disaster Management Act, 2005 order for the period 22.08.2020 to 31.08.2020 following restrictions :-

1. Curfew :-

- **Weekend Curfew :-** Total Curfew on Saturday and Sunday in all the municipal towns of District Jalandhar for the period 22.08.2020 to 31.08.2020.
- **Night Curfew :-** Movement of individuals for all the non-essential activities shall remain prohibited between 7.00 P.M. to 05.00 A.M. within Municipal limits of District Jalandhar throughout the week.

However, essential activities and services, movement of persons and goods on National and State Highways, inter state & inter state movement of persons and unloading of cargo and travel of persons to their destinations after disembarking from buses, trains and aeroplanes will be permitted. Essential services include services, related to health, agricultural and related activities, dairying and fishery activities banks, ATMs, stock markets, insurance companies, on-line teaching, public utilities, public transport, industry in multiple-shifts, construction industry, offices both private and government, media both visual & print etc.

Movement of persons and students in the connection with all kinds of examination, admission/entrance tests conducted by Universities, Boards and other institutions shall be permitted.

Identity Cards Carried by the above exempted categories of persons/ Industrialists/ workers/ employees/ officers/transporters/teachers/students/drivers/Security guards/ essential supply providers will be considered as their curfew pass. No separate curfew pass will be required by them.

Noted: Shops that are not covered into the above Categories are open on Monday, Wednesday and Friday.

The above roster can be reviewed in accordance with circumstantial conditions, if any arises at any time in future.

3. Vehicles :

- Only 3 person including driver will be allowed in a 4-Wheeler Vehicle.
- All buses and public transport vehicles to allow sitting for 50% capacity with no person standing.


4. Ban on Gatherings : There will be a ban on all social, political, religious gatherings, protests and demonstrations through out the District. However, gatherings relating to marriage and funerals shall be allowed only for 30 persons and 20 persons respectively.

Strict action will be taken against the organisers and main participants for violation of orders u/s 144 of Cr.PC.

5. Government and Private offices :

Government and private offices shall operate with 50% staff strength till the end of the month i.e. not more than 50% of employees would be permitted on a particular day. The Heads of Offices would restrict public visitors in Government offices and encourage use of on-line Punjab Grievance Redressal System (PGRS) and other on-line tools so as to minimize person to person contact in offices.

6. Activities not mentioned in these guidelines from para 1 to 5 would be governed by the guidelines issued vide order no 14626-35/MC-4/MA Dated 31-07-2020 of this office.-
